reassurance to members as GFWC Alabama and the nation enters the New Year with the COVID-19 pandemic.

We embarked upon 2021 with many of the same challenges that we hoped to leave behind in 2020. The most important to the Federation currently, is growing concern with the rise in COVID-19 new cases and fatalities in a lot of Alabama counties. Please know that the GFWC Alabama Federation of Women's Clubs is carefully monitoring both the National and State news, reading the CDC Guidelines, State of Alabama Department of Public Health Guidelines, consulting a physician associated with the CDC, and has now added updates from the United States Department of the Army to the GFWC Alabama list of trusted sources on the COVID-19 pandemic. Using statistics, reports, and advice obtained from these sources, coupled with the knowledgeable advice of the GFWC Alabama Executive Committee, the Executive Committee will continually evaluate upcoming events scheduled through May 31, 2021. This has been the practice of GFWC Alabama since June 1, 2020. We want ALL clubwomen to feel confident knowing that if at any time after obtaining statistics, reports, and advice from our trusted sources, the GFWC Alabama Executive Committee will make prompt decisions regarding scheduled events to increase the health, safety, and wellbeing of GFWC Alabama members. ### *Reporting Deadline - February 1*

After all the emails, letters and social media posts, I am confident that everyone knows that the deadline for submitting reports is February 1. Remember if you mail reports, they must be postmarked by February 1st. If you elect to email your reports, then you have until 11:59 pm on February 1. ### *Louise M. Wilson Outstanding Clubwoman - March 1*

The Louise M. Wilson Outstanding Clubwoman award is given annually at the GFWC Alabama Annual State Convention. This award is given to the Alabama clubwoman who, in the opinion of the judges, has given of herself and typifies the real Alabama clubwoman. Entry rules for this award can be found in the RACS Manual and in your AFWC Yearbook pages 102-103. The application deadline for this state award is March 1.

### *GFWC Jennie Award - March 1*

The GFWC Jennie Award honors one clubwoman from each GFWC Region for outstanding commitment to club, community and family. They are chosen by their clubs to compete at the state, regional and national levels for the Federation's highest honor. The Jennie Award Nomination Form may be found on the GFWC Alabama website, in the RACS Manual and in your AFWC Yearbook pages 104-106. The nomination deadline for the Jennie Award is March 1.

### *Antionette Stallworth Givens Award for Outstanding Alabama Juniorette - March 15*

Each Juniorette club is encouraged to vote on their own Outstanding Juniorette Clubwoman and encourage her to submit the application for the Alabama Outstanding Juniorette. The application may be found in the RACS Manual and in your AFWC Yearbook on pages 109-115.

### *Scholarships and More Scholarships - March 15*

There is the \$500 President's Scholarship, the \$500 Sue Shaw Juniorette Scholarship, the \$1000 Sue & Virginia Hester Special Education Graduate Scholarship, and the \$1500 Kitty Stone Graduate Scholarship. Encourage women in your community to apply. The deadline is March 15, and the application may be found on the GFWC Alabama website and page 118 in the AFWC Yearbook.

**ARTICLE IV-DUES AND FINANCES-SECTION 1. DUES**

1. *Clubs in arrears for dues after February 1 shall forfeit representation at the state convention, and those in arrears by the end of the fiscal year shall forfeit membership in the Federation.*
2. *Clubs who increase membership up to February 1 and pay dues on such increased membership shall be entitled to such additional representation at the state convention as such increase permits.*

I will be notifying ALL District Directors of any clubs within your District who have not paid dues as of now, in the upcoming weeks. I would appreciate your full efforts as we work together in notifying these clubs, so all dues are received **NO LATER THAN** February 1.
