



GFWC Alabama 2020 Voting Results

As the 2020 Convention was canceled due to the COVID-19 pandemic, there still remained multiple pieces of business to be taken care of prior to the conclusion of the 2018 - 2020 Administration. This included the membership voting on Bylaws and Resolutions amendments, an Honorary Membership and the elections of officers for the 2020-2022 administration.

Voting Delegates from the Board of Directors and club delegates were required to register. The list of eligible voters was confirmed by the Credentials Chairman, Roberta Atkinson. Ballots were then mailed to the registered voting delegates and returned to AFWC HQ.


